Board President, John McCleery, administered the Oath of Office to appointed Board Member Allen Thompson.


Superintendent, Dr. Dinger, reviewed Board Policies related to Curriculum and Content.


Motion by Member Oakman seconded by Member Croxton to adjourn the meeting. After a voice vote, all in favor, motion carried.
