The Board reviewed the School Improvement Goals.

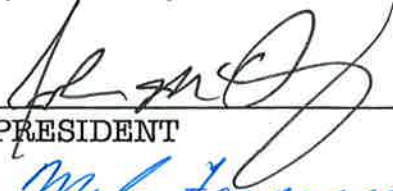
