NOTICE TO BIDDERS

The Bushnell Prairie City Community Unit School District #170 will receive sealed bids for:
Interior Renovations at Elementary School - Bushnell, Illinois

Bids shall be delivered in a sealed bid envelope to the District Business Office, 845 Walnut Street, Bushnell, Illinois, 61422 prior to 2:00 p.m. prevailing time June 3, 2021

Pre-Bid meeting will be held on May 27, 2021 at 3:30 p.m. prevailing time at the Project Site (Elementary School). Meeting will begin at Bushnell Prairie City Elementary School, 345 East Hess Street. (All Bidders are requested to attend this meeting to participate in a walk through of the Project Site. Covid -19 protocols as per State of Illinois Executive Mandates apply.

Bids shall include:

1. Properly completed Proposal Form in duplicate.
2. Bid Deposit in the amount of 5% of the Base Bid.
3. Not less than the prevailing hourly wage rate as determined by the Illinois Department of Labor pursuant to Illinois Revised Statutes, Ch. 489, Sec.39s-1 et. seq.

All Bidders are advised that all work of this Contract shall be subject to the provisions of the "Illinois Prevailing Wage Act." Prevailing wage rates have been determined and are on file at the Office of the State of Illinois Department of Labor, telephone (217) 782-6206 or on the website (<http://www.state.il.us/Agency/IDOL/rates/EVENMO/MCDONOUGH.htm>).

All Bidders shall submit and enclose with their bid a notarized certification that the Contractor is not barred from bidding on the Contract as a result of a violation of either Section 33 E-3 or 33 E-4 of Article 33E, Public Act 85-1295 (Senate Bill 2002) effective January 1, 1989. Certification is located in the Proposal Form, Section 00300, of the Project Manual.

During the performance of this contract, the Contract shall not discriminate against any employee or applicant for employment on the basis of race color, creed, national origin, gender, age or any other basis in violation of any applicable law, rule, regulation or ordinance, and shall otherwise perform in accordance with all such laws, rules, regulations and ordinances.

Bids shall be accompanied by a bid bond, bank draft, certified check or cashier's check in the amount of five percent (5%) of the Base Bid, made payable to the Bushnell Prairie City School District #170. Failure of Bidders to submit bid bond, certified check or cashier's check in amount to cover proposals bid upon is cause for rejection of bid.

Successful Bidder will be required to provide Surety Performance Bond and Labor and Material Payment Bond, each equal to 100% of the Contract cost on prescribed forms within ten (10) days after notice of acceptance is issued by Owner. Surety on bond shall be by duly authorized company acceptable to Owner.

The Bushnell Prairie City School District #170 reserves the right to reject any or all bids and reserves the right to waive any irregularity in bidding, which in their considered opinion is warranted. No bid shall be withdrawn for Sixty (60) days after opening of bids without written consent of the Owner.
